Google is STRONGLY encouraging a change to HTTPS website certificates, which in the past were used by financial and ecommerce websites. Google wants all websites to move toward more security.

Google's STRONG encouragement to date has been seen as:

- * placing "Not secure" to the left of your url in the address bar
- * not allowing any changes to AdWord campaigns (recently named: Google Ads) without the HTTPS certificate

We expect more Google sanctions to come. Each server has a unique offering of certificates. One of our servers has a no-cost HTTPS certificate which meets Google's requirements.
